Project meetings

Kick-off meeting in Koblenz



The OCOPOMO kick-off meeting took place in the premises of the University of Koblenz-Landau on 3-5 February 2010. It has been an opportunity to introduce each other, present an overview of the work to be done in the first part of the project, and to share and discuss key issues for the successful development of the project.

Apart from management issues, the main topics discussed have been the user requirement analysis. Users in the context of OCOPOMO are at first place the regional administrations participating in the project consortium, relevant stakeholders from the policy cases, as well as the policy modelling and scenario process design experts.

Second project meeting in Warsaw



The second project meeting has been hosted in the premises of the University of Warsaw on 16-17 of June 2010. This meeting mainly served to finalize the 1st stage of the project, i.e. the user requirements analysis (resulting in the completion of the first deliverable D 1.1) and to start with the policy modeling and scenario design as well as Architectural design of IT solutions to be developed in the project.

... the CROSSROAD workshop at the 9th international IFIP EGOV conference in Lausanne (Switzerland). The IFIP EGOV conference and the co-located ePart conference took place 30th August till 2nd September 2010. The conferences attracted about 150 participants, mostly from academia. Maria Wimmer, coordinator of OCOPOMO, presented the project in the workshop of CROSSROAD.

... the consultation Workshop on FP7 WP2011-2012 ICT for governance & policy modeling, which has been organized by the European Commission, DG Information Society and Media Unit H2 - ICT for Government and Public Services in order to defining the new focus on "ICT for Governance and Policy Modelling" as part of the 2009-2010 FP7 Work Programme. Maria Wimmer, coordinator of OCOPOMO, participated in the workshop.

Stakeholders' requirement analysis

A first research report has been released by the OCOPOMO consortium. It describes the stakeholders identified in each of the pilot cases (Kosice Self-governing Region and Campania Region), their requirements for the policy modelling, scenario processes and the integrated ICT toolbox supporting policy modelling and collaborative scenario development. Moreover, it outlines the way in which the OCOPOMO approach will be applied in these two pilot cases.

The first pilot case applies to Kosice Self-governing Region (KSR) and will deal with utilisation of renewable energy sources. Basic focus is set on issues of heating and possibilities of energy savings in this area. The second pilot case applies to Campania Region and structural funds enforcing competitiveness and cohesion. Knowledge transfer and its impact on SME's development will be put in the spotlight. For KSR two groups of stakeholders were defined: internal stakeholders (KSR authorities along with the related entities) and external stakeholders at different levels, i.e., international (European Union), national (Slovak government) and regional (energy producers, energy consumers, NGOs etc.). For Campania Region, the following stakeholders were identified: policy makers, authorities managing structural funds, funding beneficiaries and end users (NGOs, citizens, companies etc.).

Based on this analysis, requirements have been defined. The requirements are the basis for the subsequent activities in policy modelling and the OCOPOMO platform design. They shall guarantee the quality and usefulness of the tools to be designed to fulfill the OCOPOMO objectives.
